<u>A RESOLUTION AUTHORIZING THE VILLAGE OF WINNEBAGO TO REPLACE</u> 2011 CASE SR 250 SKID LOADER WITH A 2024 CAT 259D3 TRACK SKID LOADER

WHEREAS, the Village of Winnebago recognizes the importance of maintaining a modern and efficient fleet of equipment for the benefit of the community; and

WHEREAS, the current 2011 Case SR 250 skid loader has served its useful life and is in need of replacement to ensure continued effectiveness in public works projects; and

WHEREAS, the Village of Winnebago has identified a suitable replacement, the 2024 Cat 259D3 Track skid loader, which is technologically advanced and meets the operational needs of the community; and

WHEREAS, the purchase of the 2024 Cat 259D3 Track skid loader is approved in the 2024 Streets and O/M Budget, and funding for this item will be sourced from the Village O/M Dept. Depreciation and Street Dept. large equipment expense line items; and

WHEREAS, the recommended purchase is from Altorfer Caterpillar in the amount of \$43,999.00, and after the trade-in of the Case SR 250 valued at \$21,500.00, the purchase price falls below the anticipated budget; and

NOW, THEREFORE, BE IT RESOLVED by the Village Board of the Village of Winnebago that:

The Village Board hereby authorizes the replacement of the 2011 Case SR 250 skid loader with a 2024 Cat 259D3 Track skid loader.

The Village Board approves the necessary budgetary allocations for the purchase of the 2024 Cat 259D3 Track skid loader, including any associated costs such as equipment modifications, accessories, and delivery.

The Village Board authorizes the Village Administrator or designee to enter into negotiations and execute any required agreements with Altorfer Caterpillar for the purchase of the 2024 Cat 259D3 Track skid loader.

The Village Board acknowledges that the purchase of the 2024 Cat 259D3 Track skid loader is in accordance with the approved 2024 Streets and O/M Budget, with funding sourced from the Village O/M Dept. Depreciation and Street Dept. large equipment expense line items.
