# **ORDINANCE NO.** <u>2012- 03</u>

# AN ORDINANCE ADOPTING THE ROCK RIVER WATER RECLAMATION DISTRICT (RRWRD) CODE OF ORDINANCES FOR SEWER SYSTEM AS VILLAGE OF WINNEBAGO'S ORDINANCES FOR OPERATION AND MAINTENANCE OF SEWER SYSTEM IN VILLAGE OF WINNEBAGO

WHEREAS, the Rock River Water Reclamation District (RRWRD) and the Village of Winnebago (Village) have entered into an Intergovernmental Agreement dated December 21, 2011, with subsequent Amendment No. 1 approved by the Village Board on April 2, 2012, for the District to acquire ownership and maintenance of the Village's sewer collection system and treatment facility; and

WHEREAS, one of the provisions in the aforesaid Intergovernmental Agreement is that prior to conveyance of ownership and maintenance of the Village's sewer collection system to the Rock River Water Reclamation District, in order that the Rock River Water Reclamation District may properly and completely perform its duties and operate the sewer system, the Village shall adopt the Rock River Water Reclamation District's Code of Ordinances as the Village's own ordinances to be enforced, with said Rock River Water Reclamation District Code of Ordinances replacing and superseding any current Village ordinances or parts thereof in conflict with the Rock River Water Reclamation District's Code of Ordinances; and

WHEREAS, the Rock River Water Reclamation District and the Village of Winnebago are in the last stages of the transfer whereby, pursuant to statutory requirements, the Rock River Water Reclamation District and the Village shall soon be

presenting a joint petition to the Circuit Court of Winnebago County to permit the acquisition; and

WHEREAS, the attached complete copy of the Rock River Water Reclamation

District's Code of Ordinances accurately reflects the exact content of the current Rock

River Water Reclamation District Code of Ordinances in effect.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WINNEBAGO, ILLINOIS, AS FOLLOWS:

### SECTION 1

The Rock River Water Reclamation District's Code of Ordinances, shall be and hereby are adopted in the form as attached to the instant ordinance as and for the Code of Ordinances of the Village of Winnebago pertaining to the provision of sewer services, which sewer services are now to be taken over by the Rock River Water Reclamation District, and with any future amendments by the Rock River Water Reclamation District to said Code to automatically take effect in the Village of Winnebago as and when said amendments are passed by the Rock River Water Reclamation District.

### **SECTION 2**

Any current Village of Winnebago ordinances or parts thereof in conflict with the Rock River Water Reclamation District Code of Ordinances are hereby repealed, but any and all other non-conflicting provisions of said Village ordinances shall remain in full force and effect.

## **SECTION 3**

This ordinance shall take effect immediately upon its passage, approval, publication and in pamphlet form of three copies of such ordinance at the Village of Winnebago, Illinois, Office.
