# ORDINANCE NO. 07- €

AN ORDINANCE REGULATING AND RESTRICTING THE USE OF THE PUBLIC PARKS WITHIN THE VILLAGE OF WINNEBAGO, ILLINOIS, AND REVOKING, SUPERSEDING, AND REPLACING IN ITS ENTIRETY ORDINANCE NO. 76-10 PREVIOUSLY PASSED RELATING TO THE SAME

WHEREAS, to promote the public health, welfare, and safety, and protect and safeguard against injury to person and damage to property, it is necessary to regulate and restrict the use of all public parks within the corporate limits of the Village of Winnebago, Illinois; and

WHEREAS, Ordinance No. 76-10 was previously passed by the Village Board on August 2, 1976, regarding the above matter, but only addressed the public park at the corner of Main Street and Benton Street in the Village because at that time such was the only park in the Village of Winnebago, Illinois; and

WHEREAS, since there is now more than one public park in the Village of Winnebago, Illinois, and it is anticipated in the future there will be additional public parks, and the fine range set forth in Ordinance No. 76-10 is no longer practical, it is necessary to rewrite Ordinance No. 76-10, and replace and supersede the same with the instant ordinance.

**THEREFORE, BE IT ORDAINED** by President and Board of Trustees of the Village of Winnebago, Illinois, as follows:

### **SECTION I**

All public parks within the Village of Winnebago, Illinois, shall be open to the general public between the hours of 6:00 a.m., and 10:30 p.m., daily

#### **SECTION II**

It shall be unlawful for any person or persons to engage in any recreational activity within any public park within the corporate limits of the Village of Winnebago, Illinois, or be within such public park between the hours of 10:30 p.m., and 6:00 a.m.

## **SECTION III**

Any person violating any provision of this ordinance shall be fined not less than \$75.00 nor more than \$500.00 for each offense.

THIS ORDINANCE shall be in full force and effect from and after its passage, approval, and publication, as provided by law

### **SECTION IV**

Ordinance No. 76-10 entitled "An Ordinance Regulating and Restricting the Use of the Public Park Within the Village of Winnebago, Illinois", which ordinance was passed and approved on August 2, 1976, shall be and hereby is revoked, superseded, and replaced in it entirety by the instant ordinance, effective immediately after its passage, approval, and publication in pamphlet form as provided by law.
