# ORDINANCE NO. 2023-

## ORDINANCE AUTHORIZING SALE OF SURPLUS PERSONAL PROPERTY (PUBLIC WORKS DEPARTMENT DUMP TRUCK WITH SNOW PLOW)

WHEREAS, the Village of Winnebago, Illinois, previously purchased and currently holds title to one (1) 2011 Ford F-350 4x4 Dump Truck, bearing Vehicle Identification Number (V.I.N.) 1FDRF3H66BEA324998, with central hydraulics including a Knapheide dump bed with fold down sides, as well as an attached Western 9 foot snowplow, and an odometer reading of approximately 64,200 miles, utilized in work duties of Village Public Works Department employees; and

WHEREAS, the Village of Winnebago has purchased a newer model, namely a 2023 Chevrolet 3500 One ton dump truck with a snowplow utilized for the same purpose as the aforesaid 2011 vehicle; and

WHEREAS, pursuant to Chapter 65 of the Illinois Compiled Statutes, Section 5/11-76-4, whenever a city or village incorporated under any general or special law, other than a city or village of 500,000 or more population, owns any personal property which in the opinion of a simple majority of the corporate authorities then holding office, is no longer necessary or useful to, or for the best interests of the city or village, such a majority of the corporate authorities then holding office, at any regular meeting or at any special meeting called for that purpose, by ordinance may authorize the sale of that personal property in such manner as they may designate, with or without advertising the sale; and

WHEREAS, due to the fact the Village of Winnebago has purchased a newer model vehicle utilized for the same purpose as the aforesaid 2011 dump truck with snowplow, continued ownership by the Village of Winnebago of the aforesaid 2011 dump truck with

snowplow is no longer necessary for operations in the Village of Winnebago, and thus not in the best interest of its citizenry to retain the same.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Winnebago, Illinois, as follows:

The Village Clerk shall be and hereby is authorized to place an advertisement in the News Gazette or other newspaper of general circulation within the Village of Winnebago to advertise for sale the aforesaid 2011 Chevrolet Ford F-350 4x4 Dump Truck with 9 foot snowplow in its "AS IS" condition, with no express or implied warranties whatsoever, requesting submission of sealed bids on the same within a given time period, and indicating that the Village of Winnebago reserves the right to reject any and all bids.
