Background Information:

It has been the desire of the Board to codify the ordinances into a municipal code book. This codification will reduce and arrange the ordinances in a logical order and provide a searchable index for these ordinances. This code is not a complete listing of all ordinances but is a compilation of general ordinances approved by the Village of Winnebago.

Recommendation:

To approve the proposal received from CivicPlus, LLC for the scope of work specified in the agreement attached to the resolution referenced above.

Contract/Invoice:

A copy of the quote (#Q-32180-1) is attached. Invoicing will be in four segments as work progresses. Each of the four payments will be 25% (\$3,440.63) of the quoted amount of \$13,762.50. The first is due upon signing the agreement, followed by 25% upon submission of the Legal Memorandum, 25% upon the submission of proofs; and the final 25% upon delivery of the completed Municipal Code.
